

GRAFFITI IN POINT OF WOODS -PLEASE REPORT IT ASAP





You may have noticed the graffiti that popped up on our Point of Woods walls last month. Many of you didn't get a chance to see it. That is because the graffiti was reported to the police and removed in less than 24 hours.

If you see graffiti anywhere

in Point of Woods the first thing you should do is report it to the police, then notify the HOA.

We would like to aim to have graffiti reported and removed within 24 hours if at all possible. The sooner you report it, the sooner we can get rid of it.

KIDS AT PLAY – EVERYONE PLEASE READ!

We have had a few complaints about children playing in parking lots or in front of homes.

We want to make it clear that children have every right to play in our parking lots, on our sidewalks and in our common areas. They are not restricted to playing at the playground.

However, parents need to make sure their children are watching for vehicles, being respectful of others property, playing nice with others, and not littering. Small children should ALWAYS be supervised by adults whether they are riding a bike in a lot or playing at a playground.

On the other hand we all know there A LOT of kids in the neighborhood as well as pets. We all need to be aware of our surroundings. Please drive slow and carefully in our lots.

The HOA has no control over the behavior or supervision of children. If you have a concern that involves children you should speak with the parents directly if possible. If you don't know who the child belongs to or have failed to communicate with their parents then you should call the non-emergency police. Officers are happy to come out and discuss any concerns with parents.

In addition, common area trash cans are not for personal trash. Please use your own trash can for personal trash. If you are cleaning out your car, that trash should also be taken home.

STORING YOUR TRASH CANS

Please remember trash cans must be stored in your back yard between trash pickups. NO CANS MAY BE STORED IN YOUR FRONT YARD OR LEFT IN COMMON AREAS OR ON CURBS.

If you know who is leaving their trash can out, report them. If you are leaving your can out you know who you are and you will receive a violation.

Please help keep our neighborhood clean and put your cans away.

NEW HANG TAGS

We would like to give everyone a heads up that we will be getting new hang tags again this year. We will be passing them out in **September**.

Please remember that we are doing this to ensure that dues are paid and there are not homes with multiple sets of passes.

DOG OWNERS

Please remember to pick up your dogs waste and dispose of it in a closed container. Not only is it gross and attracts rats, it is the law. Police officers can and will ticket you. This includes your back yards.

Also, <u>dogs should always be kept on</u> <u>a leash at all times.</u> Please report unleashed dogs to animal control.

DON'T FORGET-PAY YOUR DUES!

HOA assessment fees pay for all of our bills like landscaping, parking lot repairs, police patrols, trash clean up, new lights, community events, insurance costs, etc.

Assessment fees are \$136.47 per quarter and are due January 1st, April 1st, July 1st and October 1st. If you have any questions, please let us know.


