SNOW REMOVAL AND WHAT YOU'RE RESPONSIBLE FOR



Blade Runners, our landscaping company, also does our snow removal for us. They plow our lots and clear the public sidewalks along Stonewall Rd. If your lot has been missed or you have any other issues. please email Nikki at nikki@pointofwoodshoa.com. She is the contact for Blade Runners. If you do not have email, you can call the emergency line and they will get in contact with her.

Please note the HOA is not responsible for removing snow from parking spots or the sidewalks surrounding your homes.

Homeowners must shovel the sidewalks surrounding their homes. This is City Code. You can be sited for not doing so and if someone falls in front of your home because you failed to clear your sidewalk, you

will be held liable.

Parking spaces should also be cleared by the homeowner. When shoveling parking spots or sidewalks, please pile the snow into your yard or common areas. **Do not pile it in the parking lot or sidewalks.**

PLAY GROUND EQUIPMENT REPAIRS AND NEW CITY LIGHTS

In fall of 2014 all playgrounds were inspected for damage. We have 2 large playgrounds located off of Stonewall Rd. (behind Piney Point Ct and between Shady Grove Cir.), and 2 smaller ones located on Piney Point Ct. and between Laurelwood Ct. and Willow Glen Ct. The inspection cost was \$2,000.

We found that repairs were needed

to cover exposed bolts, secure equipment, and repair /rebuild a horse. In addition, all swings were inspected and secured. The repair total was \$3,450.

We have also installed 12 new city lights. The cost of new lighting was \$18,618. We hope to continue making improvements throughout the neighborhood.
