If you do not have email, you can call the emergency line and they will get in contact with her.

Please note the HOA is not responsible for removing snow from parking spots or the sidewalks surrounding your homes.

Homeowners must shovel the sidewalks surrounding their homes. This is City Code. You can be sited for not doing so and if someone falls in front of your home because you failed to clear your sidewalk, you

will be held liable.

Parking spaces should also be cleared by the homeowner. When shoveling parking spots or sidewalks, please pile the snow into your yard or common areas. **Do not pile it in the parking**

New City of Manassas Trash Cans-Please Store Them Properly

As you know, the city started a pilot program in Point of Woods 1 & 2 to try out city provided trash cans.

The idea is city provided trash cans will encourage residents to put trash out in cans rather than piling it up on the curb. This will make our neighborhood cleaner, more appealing, and cut down on rodents. It also saves residents money on trash cans.

However, we are seeing a lot of cans being stored in front yards and even left on the curb. The same rule applies to city provided cans; trash cans must be stored in your back yard or side yard. Residents will be cited if trash cans continue to be stored in front yards.
